What are the implications for you and your role? How may the AVMs effect the valuers work positive and negative? Share your experience with the use of AVMs.

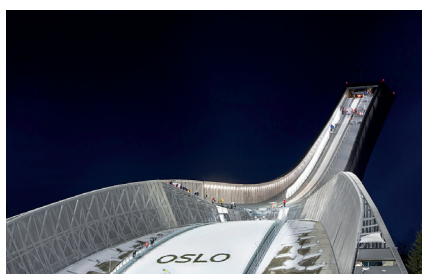


Presentations on these themes and other topical issues are important and very welcome!
